Panama City's island of Fuerte Amador is located on the west side of the city, adjacent to the Pacific Coast entrance to the Panama Canal. With skyscrapers of glass filling the downtown area and along the coast, this city is to all appearances a prosperous place of almost 900,000 people. The city is surrounded by a large belt of tropical rainforest. **7 AM to 6 PM**

PANAMA CANAL FULL TRANSIT NEW LOCKS

The Panama Canal Expansion is the largest project at the Canal since its original construction. The Panama Canal expansion is based on six years of research, which included more than 100 studies on the economic feasibility, market demand, environmental impact and other technical engineering aspects. Works on the Panama Canal Expansion began on September 2007 at a total cost of US\$5.2 billion. **6 PM to 4:30 PM**

CARTEGENA, COLOMBIA

This modern and bustling city, seaport and commercial center still boasts much of its original Spanish colonial architecture. Explore this beautiful and historic city's walled Old Town. Its fortress walls, quaint, narrow streets and balconied houses are all vivid reminders of its former colonialists.
